**2Q EPS beat on stronger sales:** Strong 2Q26 results with record net profit of NT \$8.6bn and EPS of NT\$5.12, beat MSe/consensus by 35%/32%. Revenue is up 44% Q/Q and 82% Y/Y, mainly driven by strong memory revenue growth (54% sales mix vs. 45% in 1Q26 and 26% in 2Q25). GM is at 4.43% vs. 4.49% in 1Q. OPM came in at 2.62% vs. 2.68% in 1Q. Management also highlighted improving operating efficiency, with record ROWC and lower working capital intensity.

**Slower 3Q outlook on memory and pull-in:** Management maintained a positive 2H26 outlook, supported by AI demand and continued memory supply tightness, but 3Q26 revenue guidance only implies 5% Q/Q growth. We believe lower memory price increases and customer pull-ins in 2Q26 likely temper near-term upside. Nevertheless, we still expect healthy earnings growth, supported by AI demand, LaaS expansion and improving operating efficiency.

**Remain OW:** We believe AI-related demand, memory content growth and expanding value-added services should continue to support earnings growth.

- Global semi inventory drops, reflecting strong mobile device demand.
- Market share expands.

#### Risks to Downside

- Margin trends down dramatically amid slower-than-expected non-3C business development and pressure on client margins.
- Global semi inventory rises, reflecting poor mobile/PC device demand.
- Market share is lost.
